## PRE-K - 2 APPLE PRODUCT PRESENTATION

Mr. Granieri, Mr. St. Onge, and Mr. Maynard, Kim Maynard; and Phil Miano, from BOCES.

Following an introduction by Mr. Granieri, Mr. Maynard led a demonstration and discussion of iPads and Apple applications.

The adoption of Apple products for these grade levels was agreed upon following research with focus groups, discussion with Apple, vendors, and other District entities. They were piloted at 79th Street School beginning a year ago. iPads are faster and easier than personal computers.

Physical advantages of iPads as opposed to laptops for early learners include an intuitive touch interface which mirrors natural interaction; direct manipulation, which reduces cognitive load; and better suited for developing motor skills

The Apple classroom offer real-time student monitoring; guided access to keep students focused on specific tasks; easy content sharing through air drop; and maintaining an organized and productive learning environment.

iPads include extensive built-in accessibility options that support diverse learning needs, such as voice-over for visually impaired students, closed captioning for hearing impaired learners, assistive touch for students with motor skill challenges. These features make iPads more inclusive and adaptable to individual student needs.

Additionally, iPads are lightweight and easy for young children to carry And the touchscreen interface is intuitive and user-friendly for small hands.

Multi-sensory learning benefits include built-in cameras for documentation and creative expression, as well as high-quality speakers for audio learning. iPads feature microphones for voice recording and language development and other integrated tools to enable rich,

interactive experiences that support different learning styles and developmental needs.

iPads facilitate easy sharing and collaboration among students. Group activities and projects are more interactive with iPads.

Activities like drawing and tracing letters are more natural on an iPad help develop fine motor skills.

At this time, iPads offer the largest range of educational apps designed for young learners. iPads offer significant advantages for early education through age-appropriate physical interaction, a robust educational content ecosystem, comprehensive management tools, superior accessibility features and long-term cost benefits.

These benefits make iPads a superior choice for creating engaging, effective learning environments for young students.

Board members were able to see examples of education in action using the iPads as part of the presentation, including viewing a demonstration video created by grade two student Malachi Stonebeck.

Parenthetically, Mr. Maynard shared that NFHS was the first school to use iPads to score a swim meet.

Teacher Miss Larock shared that her students love working with the iPads.

Next steps include purchasing these through Erie 1 BOCES. This will be on the agenda February 27, 2025. They will replace the personal computers, which are at the end of their life cycle. iPads could be in classrooms and in use by September. The cost is about \$1,000,000 for 1,700 units; this is BOCES-aidable.

"Staff to Grants" refers to taking funds out of reserved federal money and using it. This is to protect the funds. Other considerations include the need to fund summer programming formerly funded by ARP funds and the loss of grants which are expiring.

Current funding gap: \$3,255,571 with use of reserves (\$4,171,126 before reserve). Mr. Laurrie is hopeful that Foundation Aid will increase once the legislature starts its work on the budget.

## **COMMENTS:**

Students from NFHS joined with students from North Tonawanda and Niagara-Wheatfield Monday to visit the Museum of Tolerance. This is the third year this collaboration has been in place.

The ramifications of the PowerSchool data breach are now out of our hands. Those affected will be notified by PowerSchool/Experian.

Congratulations to Bloneva Bond Primary Assistant Mrs. Dorothy Brundidge, who has been selected to receive a Black Achievers Excellence Inc. award from Buffalo Construction Consultants. She will be honored at a Red Carpet Gala Reception on Saturday, March 15th, 5:30pm at the Niagara Falls Convention Center.

Both NFHS Bowling teams won the league; the boys' record is 14-0 and the girls' is 12-2. Ally Ventry is the highest scoring female bowler. Swimmers also are going to competition. All the NFHS wrestlers will be competing in the State competition.

Mr. Laurrie shared his thoughts on the possibility of the federal Department of Education being eliminated. We do not know yet if that will happen, as it would require a congressional action. It may happen, so the District is preparing. There could be an impact of many millions of dollars in funding, including that designated for special education and Head Start. Perhaps the states would administer those funds on behalf of the federal government, but would it be the full amount? There is a concern that entitlement dollars and grant dollars could go away.

On the other hand, some State testing is required in order to get federal money. Hopefully those regulations also would go away, as some of those tests are not useful or indicative of anything pertinent to students. For example, the NAEP national assessment hopefully be eliminated. It is useless.

Furthermore, there are federal rules in conflict with State rules. It all remains to be seen.

Regarding National Grid, the District still is working on the needed easements. LPS in not an issue because the required land is District property. The easement at GPS requires the use of City-owned land; the City Council will address the matter at its February 26, 2025 meeting.

Thank you to Mr. Smeal, who has worked to secure multiple sources for rock salt to keep our walks and lots safe. Consequentially, the District has no salt shortage.

Niagara Falls High School students took part in an Environmental Summit on Thursday in Erie County and captured first place out of seven schools from WNY. Kudos to our NFHS Environmental students.

District prep school robotics teams competed last week for a chance to enter the NYS Robotics Championships on March 5, 2025 in Syracuse, New York. Seven District teams qualified, five from Lasalle Prep and for the first time two teams from Gaskill Prep. We are proud of all of our students with special recognition to the up and coming teams at Gaskill.

Monday, February 17, 2025 is President's Day with no staff or students in attendance.

It was a difficult week for our District family, as 44 year-old parent Nea Crockett suffered a fatal heart attack while attending Senior Night at NFHS. The District offers its support, blessings, and love to NFHS. Support for her son, Nashaun, is everywhere and growing as District staff comes together to offer what it can. Today, Ms. Crockett is the most important person to remember. Her services will be held Monday at Christ Redemption Tabernacle.

A simple majority vote in favor would pass the budget in May.

Mr. Laurrie commented that at least one district is moving employee salaries from federal grant money-funded lines back to the general fund. He feels it is pre-mature to do so at this time.

The Tax Cap was presented and is attached. The BAN to pay for ABOFA caused a \$1.3million interest to be paid this year.

The Board used reserves to balance the budget last year; Mr. Laurrie believes that will need to happen again. There are concerns that replenishing the funds may not be as easy as it had been.

Regarding the possibility of the federal Education Department being resolved, Mr. Laurrie commented that about \$12 million comes to the District through Title I, \$2.3 million through IDEA; \$2.3 million to fund Head Start an Early Head Start; and an additional \$1 million in grants. While he hopes it does not happen, it would remain to be seen whether funds would come through the State or whether they would be impacted.

# Review of the Proposed Policy(ies)

5840 Artificial Intelligence 1 of 4

SUBJECT: ARTIFICIAL INTELLIGENCE (AI) Overview

The emergence of artificial intelligence (AI) technologies, especially generative AI (GenAI), pose unique challenges and opportunities for learning environments. As these technologies integrate deeper into everyday life, the district must proactively address the implications of AI usage to ensure it enhances educational outcomes without compromising academic integrity or equity. This policy outlines the district's commitment to responsible AI integration in educational practices, balancing innovation with the core values of the district's educational mission. Further, it sets forth guidelines designed to evolve as new technologies and methodologies emerge, ensuring the district remains at the forefront of academic excellence and technological responsibility.

# Scope and Application

This policy applies to all District students, personnel, volunteers, and contractors. It integrates with, and complements, existing policies on data privacy, acceptable use, and student conduct. This policy aims to provide clear guidelines on the use of AI within the District's schools, ensuring that its application supports the district's educational goals and adheres to its privacy and security standards.

### **Definitions**

- a) Generative AI (GenAI) represents a dynamic subset of AI technologies that can create new, human-like content from extensive data training sets. This content spans across text, images, audio, and more, often mimicking human creativity and adaptability.
- b) Traditional AI refers to systems that operate on fixed algorithms and predefined rules without altering their behavior based on new data after their initial deployment.

#### Risks and Limitations

The use of GenAI comes with some risks and limitations which include, but are not limited to:

- a) Hallucinations/Confabulations GenAI can generate plausible, but false or inaccurate, information, a phenomenon known as a hallucination/confabulation.
  - b) Biases

GenAI tools learn from data created by people, which means any biases, prejudices, and stereotypes in that data can be reflected in the outputs produced by GenAI. For example, GenAI has been found to generate images and text that reinforce existing gender and racial biases. It is essential to recognize that these biases exist and to critically assess the outputs of GenAI tools to prevent the perpetuation of stereotypes and unfair treatment.

The impact of GenAI biases is particularly significant in the context of Diversity, Equity, and Inclusion (DEI) initiatives. DEI initiatives aim to create environments where all individuals have equal opportunities and are treated with respect and fairness. Biased AI outputs can undermine these goals by perpetuating inequality and exclusion, which can be detrimental to the educational mission of the district.

GenAI can also suffer from response bias, where the AI generates answers tailored to what it predicts the user wants to hear based on its training data or specific tuning.

# c) Copyright

GenAI may pose copyright issues as it may have used copyrighted material within its training data without explicit permission from the copyright holders. As a result, there are unsettled legal questions about the ownership and copyright status of GenAI's outputs, which can closely mimic or incorporate elements of existing copyrighted works.

# **Data Privacy and Security**

Information entered into GenAI may be accessible to others due to data sharing or breaches. All users should exercise caution when utilizing GenAI. Under no circumstances should any sensitive, copyrighted, confidential, or proprietary information be entered into GenAI or any other AI platform, consistent with relevant state and federal laws and District policy. This includes, but is not limited to, data protected by:

a) Family Educational Rights and Privacy Act (FERPA);

- b) Education Law Section 2-d (Unauthorized Release of Personally Identifiable Information);
  - c) Labor Law Section 203-d (Employee Personal Identifying Information);
- d) State Technology Law Section 208 (Notification of Security Breach of Private Information).

Further, if the information would not be disclosed in response to a Freedom of Information Law (FOIL) request, it should not be entered into GenAI.

The district permits teachers to determine whether students in their class may use GenAI for assignments. However, the District recognizes that disparities in access to GenAI technologies may exist and will work with teachers to ensure that no student is disadvantaged by their inability to use or decision not to use GenAI.

If teachers allow their students to use GenAI, they are expected to communicate their expectations regarding the use of GenAI clearly to their students. Further, the teacher must discuss the appropriate and responsible use of GenAI with the students. This includes talking to students about the risks and limitations of GenAI, emphasizing how students are accountable for the accuracy of their work, and, when relevant, ensuring proper citation of sources.

Student use of GenAI that conflicts with teacher instruction, District policy, regulation, procedure, or other document, such as the District's Code of Conduct, may result in investigation and/or disciplinary action.

The precursor to any AI use in-district is accomplished, vetted training.

This training can be acquired from higher education institution course work or other accreditations.

The District and the Teacher Resource Center is developing and scheduling AI specific coursework to ensure that AI is employed in the most efficient, guarded manner.

AI use will be fully integrated into the Instructional and District Technology plans.

## District Personnel Use

District personnel may utilize GenAI in accordance with this policy. However, regardless of the tools used to enhance their work, personnel are ultimately responsible for the accuracy and integrity of all work they produce. AI is intended to support, not replace, an employee's responsibility for their own work.

Training, Awareness, and Support

The district will provide training, awareness, and support to teachers in navigating the evolving use of GenAI in the classroom. This may include professional learning opportunities, workshops, and resources to enhance teachers' proficiency and confidence in using GenAI to enrich student learning. The goal is to equip teachers with

the knowledge to critically assess GenAI technologies and guide students in understanding the complexities associated with these tools. Additionally, the District may extend training, awareness, and support regarding GenAI to other District personnel who may benefit from understanding and utilizing GenAI in their roles.

# Compliance with Other Documents

When using GenAI, all personnel and students must comply with all applicable laws, regulations, and District documents. This includes Education Law Section 2-d, which requires the District to ensure that whenever it enters into a contract or other written agreement with a third-party contractor under which the third-party contractor will receive student data or teacher or principal data from the District, the contract or written agreement will include provisions requiring that confidentiality of shared student data or teacher or principal data be maintained in accordance with law, regulation, and District policy.

Applicable District documents may include the district's policies on data security and acceptable use, as well as the District's Code of Conduct.
